



Limited Warranty for Kenall TekLink Sensors & Controls Products

This limited warranty is provided by Kenall (the Seller) to you (the Purchaser) as the original purchaser of the lighting controls product. This limited warranty may be transferred to subsequent purchasers of the product as long as it is in its original factory packaging and in unused condition. Qualifying Kenall lighting controls products shall be warranted by Kenall, for a period of time, defined below, from the date of manufacture, to be free of defects in workmanship and materials that restrict the devices from normal electrical operation. Inputs to the control system from any party not acting as an agent of Kenall such as programming, scheduling, and the like, are explicitly not covered under this warranty. Kenall's TekLink controls products may include: luminaire integrated controllers, stand-alone controllers, sensors, network communication devices, and installed software. Third party components/services such as computer hardware, mobile computing devices, software, commissioning systems, installation services, remote programming, or other professional services are excluded from this Statement of Limited Warranty.

Kenall reserves the right to issue a credit or to repair or replace the defective product, at its discretion, upon notification and confirmation by an authorized Kenall agent of the defect. Kenall also reserves the right to test and examine the product if the defect is questionable. This limited warranty will not apply to loss or damage caused by: any product alteration, mishandling, vandalism, civil disturbances, acts of God, electrical surge, improper electrical supply, fluctuations of electrical current or voltage, electrostatic discharge, natural or induced mechanical oscillation, corrosive environments, normal wear and tear including discoloration due to aging or failure to follow applicable electrical codes; external site conditions, including without limitation, heavy tree cover, cellular, satellite or radio interference. This warranty shall be void for lighting controls installed into an application for which it is not intended, or intentionally damaged, or installed in abnormal environmental conditions as prescribed by Kenall. This warranty does not cover cost that may be incurred in connection with changes or modifications to the Product(s) required to accommodate site conditions and/or faulty building construction or design. In addition, this warranty does not cover costs resulting from installation of third party supplied components, failures of third party supplied components, or failures of Kenall supplied Product(s) caused by a third party supplied component.

Kenall assumes no responsibility for labor or freight costs incurred in connection with the installation, removal or replacement of products determined to be defective. To the maximum extent permitted by applicable law, Kenall hereby disclaims all warranties and conditions, whether expressed, implied or statutory, including, but not limited to, merchantability or fitness for a particular purpose, other than those explicitly provided by Kenall hereunder.

To the maximum extent permitted by applicable law, Kenall shall, in no event, be liable for any special, incidental, indirect or consequential damages whatsoever, including, but not limited to, loss of profits.

Kenall further reserves the right to change the terms of this warranty on future sales of lighting controls without prior notification and without incurring obligation and expressly disclaim all warranties not stated in this limited warranty.
